

4. KC Green Holdings, Farewell party for interns

KC Green Holdings, trained network companies in sustainable management



KC Green Holdings has issued annual Sustainable Management Report from 2012 onward. The preparation and publication of the Sustainable Management Report is carried out by KC Green Holdings. Resources on actual management activities are received from partners of KC Green Holdings. However, as there is no education on the guideline of the Sustainable Management Report, staffs of each partner felt difficulties in data report. Accordingly, KC Green Holdings provided an education on the 27th day in order to help understand the sustainable management and to manage sustainable management activities coherently and systematically.

The education was taught by Lee Yoonjeong, a researcher of the BISO of Korea Chamber of Commerce with two sessions including 'CSR and Sustainable Management Report' and 'GRI G4 guideline index.' 16 staffs from 13 domestic partners that are subject to preparation of 2018 report attended the education. It is hoped that this education would help to develop the sustainable management activities of KC Green Holdings and partners systematically and integrally. (The end)
